The following are the primary Terms and Conditions that shall define, govern and guide your registration with **Enegosyo** as a Dealer selling prepaid loading products.

1. **REGISTRATION** - As dealer, I will acquire business kits worth Php4,000.00 (*four thousand pesos*) as initial order to start my **Enegosyo** business. Inclusive in my package are:
 - 15 pcs. Retailer kits worth P300.00 each.
 - 1 pc. Enegosyo dealer tarpaulin
 - 16 pcs. Enegosyo retailer banner
 - Initial P30 loadwallet credits, upon successful registration (per retailer kit).
 - Default username/password for my web account / POS upon successful registration.

2. **SELLING**

- That in selling the products and in dealing with consumers, I will represent myself as a duly registered and independent Dealer Partner and not as an employee or agent of **Enegosyo** or any of its affiliates, subsidiaries or business partners.
- That I will sell any and all **Enegosyo** products at retail prices determined and provided for by **Enegosyo** and I will receive discount or any other benefit for each successful sale in accordance with the discount structure scheme, which **Enegosyo** may issue from time to time.
- That in no case I will make **Enegosyo** liable for any cost that can possibly incur, such as:
 - a) **The amount deducted on my personal load due to every message sent to enegosyo gateway numbers.**
 - b) Any advertisement or promotional materials, collaterals, stall, space, or effort of any kind, not duly approved or authorized by **Enegosyo**.

3. **RELOADING WALLET CREDITS** - That I agree to the following rules and procedures of the modes of payment provided below:

- The amount of cash paid to **Enegosyo** will be the amount to be loaded in my wallet except for additional charges on bills payment (P10 service charge if below P3000) and provincial bank deposits (except for BDO and BPI).
- On bank transactions such as over-the-counter deposits, internet fund transfer, phone banking and bills payment, approval is within 24 hours after enegosyo receives my reload request, or within 2 to 4 days, or on the next banking day if the deposit has been made on Saturdays, Sundays, Holidays, and on the day before Holidays.
- Enegosyo cannot guarantee "within 24 hours" bank deposit approval in the case I have encountered bank difficulties such as off-lines, finance disapproval, technical errors etc.

4. That I agree to **DEACTIVATION POLICIES** below:

- That I will acquire retailers by selling my **retailer kit worth P300.00** (*three hundred pesos*) each in complete and good condition.
- That I shall inform my direct retailers everything they need to know regarding **enegosyo's** retailer terms and conditions (from registration up to other charges) along with its operation policies and procedures in their entirety.
- That I understand and agree that any compensation to be received from the company's dealer compensation plan is related primarily to the product selling, override commission, direct referral or any other discounts which enegosyo may provide either permanently or from time to time.
- That I agree to indentify and hold the company harmless and free, from and against any claim demand, liability, loss, cost or expense including but not limited to cost of litigation, attorney's fees and damages directly or indirectly arising out of or in any way related to or connected with the **enegosyo** dealer (i) business activities, (ii) breach hereof, (iii) violation or non-compliance of national or local laws, rules and regulations.

7. Dealer registration fee are fixed and a contract is formed upon purchased of the kit. **NO REFUND** will be issued in the event that **Enegosyo** fails any expectations that I may have with my registration as **Enegosyo** Dealer Member.

8. That I will abide by all rules and regulations or any amendment thereto relating to the sale and distribution of products, which **enegosyo**, its service providers or suppliers may issue from time to time.
